**SPECIAL MEMBERSHIP:** UNDER THIS MEMBERSHIP THE STOCK FEE AND THE INITIATION FEE (TOTAL \$2,578.00) IS DIVIDED INTO FIVE (5) ANNUAL PAYMENTS. THE FIRST TWO PAYMENTS WILL BE \$530.00 THE THIRD PAYMENT IS \$518.00 AND THE FINAL TWO PAYMENTS ARE \$500.00. THE FIRST PAYMENT PLUS THE FIRST MONTH'S DUES (TOTAL \$747.30) IS DUE WITH THE APPLICATION. THE REMAINING FOUR (4) PAYMENTS WILL BE BILLED ON THE ANNIVERSARY MONTH OF INITIAL MEMBERSHIP. A SHARE OF STOCK WILL NOT BE ISSUED UNTIL THE FINAL PAYMENT HAS BEEN RECEIVED. IF YOU WERE TO DEFAULT AT ANY TIME BEFORE THE \$2,578.00 IS PAID THERE IS NO REFUND.

**JUNIOR MEMBERSHIP:** (AGE 40 AND UNDER) SAME AS ABOVE EXCEPT THE \$2,578.00 IS DIVIDED INTO TEN (10) ANNUAL PAYMENTS. THE FIRST FIVE PAYMENTS WILL BE \$265.00 THE 6<sup>TH</sup> PAYMENT WILL BE \$253.00 AND THE LAST FOUR WILL BE \$250.00. THE FIRST PAYMENT PLUS THE FIRST MONTH'S DUES (TOTAL \$482.30) IS DUE WITH THE APPLICATION.
